



# **Application Guide**

If you're reading this, you probably have an amazing project to submit to the Ingenious+ challenge. Woohoo! We are pumped for you and the incredible things you're doing in your community. Let's make sure your application hits the mark.

# **Step 1: Make Sure Your Innovation Qualifies**

Your innovation can be a product, a service, a process, or a program that solves a problem or makes the world a better place. You might be thinking... "That could be almost anything!" And you're right. We are using a broad definition of innovation to capture the wide range of awesome things young Canadians are doing. Make sure your innovation fits into one of these five categories:

- Community and Civic Engagement
- Climate Change and the Environment
- Equity and Inclusion
- Health and Well-being
- Technology and Entrepreneurship

Ideally, your project should be advanced beyond the idea or concept stage. Can you demonstrate that you've started to put the solution into action? Check mark! Projects do not have to be complete inventions or something you can make money from to qualify. You must also:

- Have a parent or guardian's permission to submit if you're under the age of majority in your region
- Be between 14 and 18 when you enter
- Live in Canada.

Decide whether you will submit on your own, or with collaborators who are part of your project. All collaborators must meet the above requirements.

# Step 2: Gather your submission elements

Before you start filling out the application form, gather up everything you will need. Make your application process nice and smooth by noting all your information in a document before beginning the online form.

You can submit your project description in writing, in video, or both. You will need to answer these questions:

- Provide a short description of your innovation. (40-60 words)
- Describe the problem or opportunity your innovation addresses. What do you hope to solve or improve? (max 500 words)
- Describe your innovation in detail, including any relevant information as to how it came about. (max 200 words)
- Tell us about your Research and Design process. What sort of background research and/or consultation have you done to support the development of your idea (e.g. consulting with people in the field or industry)? (max 200 words)
- Who does your innovation help and how? (max 100 words)
- What is currently being done to address this problem or similar problems in your community or elsewhere? How does your project differ from existing solutions? (max 100 words)
- Are there any potential barriers to implementing your solution? If so, how might you propose overcoming them? (max 100 words)
- Explain who your collaborators or partners have been, or will be, as the innovation is brought to life. (max 200 words)
- Describe how you would use the cash award to support your innovation. (max 200 words)

If you're submitting in writing, stick to the word counts listed beside each question. Focus on the process and benefits of your project and try to avoid jargon or buzzwords. We want to know about you and your project!

# Video submissions

Video submissions must be shorter than 10 minutes long.

Practice your answers to the questions above and record yourself speaking to the camera. Make sure:

- You answer every question.
- You introduce yourself and your team.
- Your face is well-lit with natural or artificial light-we want to see you!
- The video is capturing your audio clearly. Record in a quiet room and use a microphone if you have one.
- Show us your stuff! If it makes sense for the question, show us your innovation as you talk about it. Make sure we can see your project clearly in the video if you choose to include show and tell.

You can record your video in one long shot, or edit together each question. Upload your completed video to YouTube or Vimeo before beginning the online application. You will be asked to submit your video link in the application.

# **Relevant files and documents**

All submissions need to include an image that represents your project. This could be:

- An image of your innovation, either a physical object or digital rendering
- A photo from an event associated with your project
- A team photo of you and your collaborators
- An image of the problem you are trying to solve

Images must be smaller than 2MB and in .jpeg or .png format. This is your chance to show off your stuff! If your project is a thing, make sure we can see it clearly in the image.

If your project has other documents that would help us understand your innovation, you can also upload those as part of your application. Some examples include presentations, short tutorial/promotional videos (under two minutes), drawings, etc.



# Step 3: Complete the release and submit!

Before you submit your application, carefully review the Declaration/Release form with a parent or guardian. If you are under the age of majority in your province (under 18 in Alberta, Manitoba, Ontario, Prince Edward Island, Quebec and Saskatchewan, under 19 in British Columbia, New Brunswick, Newfoundland, Northwest Territories, Nova Scotia, Nunavut and Yukon), your parent or guardian must sign the form as well.

- Download <u>this form</u> if you are UNDER the age of majority in your province/territory
- Download <u>this form</u> if you are OVER the age of majority in your province/territory

You will be asked to upload your form as the first step of your application.

# Step 4: Send us your stuff... and wait.

Don't be afraid to contact us about the application process! We're here for you if you've got questions.

Once you're ready to submit, set aside one or two hours where you can focus in a quiet space and upload your answers and documents. We don't want you to miss anything, or mix up your responses.

Once you've completed all the questions in the application, hit submit and wait. We know that's the hardest part! We take time to review each application carefully. Successful applicants will be notified by May 13th, 2024.

- 1. I confirm that I am a legal resident of Canada and was between 14 and 18 years of age as of the date of my entry. If I was under the age of majority in my province or territory of residence at the date of my entry, I had the permission of my parent or legal guardian to enter the Competition. I confirm that I am not an officer, director, employee, agent or representative of any of the Sponsors or any of their respective parents, subsidiaries, affiliates, advertising and promotion agencies, or any individual or entity involved in the development, production, implementation, administration, judging or fulfillment of the Competition (collectively, the "Competition Entities"), or a member of any immediate families (defined as parents, siblings, children and spouses, regardless of where they live) or households (whether or not related) of any of the above.
- 2. I understand that I may be selected as eligible to win a regional award in the Competition sponsored by the Sponsors consisting of:
  - \$1,000 for the purposes of developing, improving and implementing the innovation

submitted in the Competition; and

- the opportunity to attend 4-5 virtual group learning and mentorship sessions (approx. value \$100 each).
- 3. I understand that I may be selected as eligible to win a National Finalist award in the Competition sponsored by the Sponsors consisting of:
  - \$1,000 for the purposes of developing, improving and implementing the innovation submitted in the Competition; and
  - the opportunity to attend 3 virtual group learning and mentorship sessions (approx. value \$250 each); and
  - National Finalist Award winners will also be invited to attend a national in-person celebration in Ottawa during Canadian Innovation Week (May 13th-17th, 2024).
- 4. I understand that if I win a regional award, I will be eligible and may be selected to win a national award in the Competition sponsored by the Sponsors consisting of:
  - \$10,000 for the purposes of developing, improving and implementing the innovation

submitted in the Competition; and

• the opportunity to attend 2-3 virtual group learning and mentorship sessions (approx. value \$250 each); and

- National Award winners will also be invited to attend a national in-person celebration in Ottawa during Canadian Innovation Week (May 13th-17th, 2024).
- 5. I understand that if I enter the Competition as part of a group and my group is chosen for an award, the cash award will be distributed equally amongst the group members.
- 6. I acknowledge and agree that the award must be accepted as awarded and may not be substituted, transferred or redeemed for cash or otherwise. The Rideau Hall Foundation reserves the right, at its sole discretion, to substitute an award of greater or equivalent monetary value if an award cannot be awarded as described for any reason. The Rideau Hall Foundation will not replace any lost or stolen awards.
- 7. I acknowledge and agree that all award recipients (including all members of a group) may be recognized on the Competition website by name, city and province or territory of residence and photos and I agree to make myself available for media interviews. I consent to the use of my name, image, photograph, likeness, voice, and city of residence and related visual/sound recordings by the Rideau Hall Foundation, without the expectation of further remuneration or notice in connection with the award and for publicity purposes relating exclusively to the Competition in any media or format whatsoever at any time or times in perpetuity.
- 8. I understand that the Rideau Hall Foundation has no control over and is not responsible for any use or misuse including, but not limited to, any alteration, modification, reuse or distortion of the photographs taken, or content submitted (or my name and city of residence) that may occur or be caused by third parties. The Rideau Hall Foundation will not be monitoring and has no control over third parties' use or misuse of the photographs or content of my submission (or my name and city of residence) displayed on the Rideau Hall Foundation website or other websites or publications.
- 9. I consent to the collection, use and disclosure by the Rideau Hall Foundation and its authorized agents of my personal information in order to process my application and administer the Competition, including awarding awards, which information is mandatory in order to participate in the Competition, and some of which information is posted on the Competition website. I understand that winners consent to the collection of additional personal information, which may include financial information, for the purposes of confirming compliance with the award use and reporting requirements set out in these Competition Rules. Entrants may be offered the opportunity to receive additional communications from the Rideau Hall Foundation or its partners about their products and programs, and upcoming contests and promotions. Personal information is collected, used and disclosed for the purpose of administering and promoting the Competition and winners in accordance with applicable privacy laws. You can withdraw your consent to use your personal information before the submission closing date, in which case your Submission will be removed from consideration.

- 10. I understand that as a condition of receiving an award, all winners will be required to use the monetary portions of their award for the purposes of developing, improving and implementing their innovation. Determination of whether a winner's activities comply with this requirement will be in the sole discretion of the Rideau Hall Foundation and supporting documentation, such as receipts, may be requested. Examples of acceptable uses of awards include, but are not limited to, purchasing materials for the innovation, marketing costs, registration of websites, purchasing equipment, and transportation costs. All winners will also be required to complete an end-of-year survey sent to them electronically or otherwise by the Rideau Hall Foundation seeking feedback on the Competition and a description of how the winner used the monetary and non-monetary portions of their award to develop, improve, or implement their innovation.
- 11. In addition to these requirements, winners of the national awards will be required to provide a progress report to the Rideau Hall Foundation three (3) months after receipt of their award. The progress report (a) must contain an update on the status of the winner's innovation and how the winner used the monetary and non-monetary portions of their award to develop, improve, or implement their innovation and (b) must be submitted to the Rideau Hall Foundation at the date specified by the Rideau Hall Foundation.
- 12. I understand that if a winner fails to (a) use an award for the purposes of developing, improving or implementing their innovation, (b) complete the end-of-year survey as required, or (c) complete and send the progress report as required (for national award winners only), the Rideau Hall Foundation, in its sole discretion, may require repayment of the monetary portion of the award.
- 13. I understand that if I am a regional award recipient, I will be invited to attend a regional celebration, which will be held in-person between March and May 2024. I understand that if I am a national finalist or a national award recipient, I will also be invited to attend a national inperson celebration in Ottawa during Canadian Innovation Week (May 13<sup>th</sup>-17<sup>th</sup>, 2024).
- 14. If I am a regional award recipient, a national finalist or a national award recipient, I:
  - a) understand that the Rideau Hall Foundation will, where necessary and only if possible dependent on health and safety travel restrictions, provide:
    - round trip economy transportation for (a) myself if I entered the Competition alone, or if I entered the Competition as part of a group and am the designated representative of my group per our application form; and, if I am under the age of majority in my province or territory of residence, (b) my parent or legal guardian from the major Canadian airport nearest my residence (selected at the discretion of the Rideau Hall Foundation) (the "Departure Point") to the city location of the regional and/or national celebration (the "Destination");

- one (1) night hotel accommodation in Destination for myself and, if applicable, my parent or legal guardian (based on standard room, double occupancy); and
- entry for myself and, if applicable, my parent or legal guardian, to the award celebration at the Destination (the "**Event**");
- b) understand that if I reside within a 350-kilometer radius of the Destination, ground transportation (including without limitation train transportation) may be awarded instead of air travel and no compensation or substitution will be provided for the difference in cost (if applicable);
- c) understand that any other costs or expenses associated with the award not specified herein will be my responsibility, including without limitation ground transportation to/from the Departure Point, meals, communication charges, room service, gratuities, optional tours, insurance and medical travel documents;
- d) understand that the Sponsors will not be responsible if weather conditions, event cancellations, or other factors beyond Sponsors' reasonable control prevent the award or part of the award from being fulfilled, and that I will not be entitled to compensation in lieu thereof;
- e) understand that I and, if applicable, my parent or legal guardian must travel on the dates and travel carriers and stay at the accommodations as determined by the Rideau Hall Foundation in its sole discretion, and all travel must be completed prior to May 18<sup>th</sup>, 2024;
- f) confirm that I have a valid passport and any other necessary travel documentation and permissions to travel to the Destination. I understand that if I am denied access to an aircraft, entry into the Destination country or return entry to the Departure Point, that the award may be forfeited (in whole or in part) and that I will be solely responsible for any and all additional costs incurred;
- g) agree to obey all hotel and Event rules and requirements, including the hotel requirement to present a major credit card. I understand that failure to follow such hotel and Event rules and requirements may result in, without limitation, ejection from the Event, non-admission to hotel and forfeiture of all or part of the award;
- h) understand that if I am travelling with a parent or legal guardian, they will be required to sign and return a Release in order to accompany me. I acknowledge that once I select my parent or legal guardian to accompany me, I will not be able to change their names;
- i) agree to conduct myself with due regard to the public conventions and morals. I will not, while a guest of Sponsors during the trip, commit an offense involving moral turpitude under local laws or ordinances. I acknowledge that my receipt of the award shall fully discharge any obligation owed to me by the Sponsors in relation to this Competition, and I hereby release and agree to defend, indemnify and hold harmless the Competition Entities and each of their respective officers, directors, agents, representatives, successors and assigns (the "Releasees") from any and all liability, claims, demands, judgments, damages, injuries, lawsuits, causes of action, death, losses, costs and expenses in connection with this Competition or the acceptance, receipt, attendance at, travel related to, defect in, delivery of, use, inability to use, or misuse or possession of the award, which I or my respective heirs, executors, administrators or next-of-kin may now or hereafter have against them or any part of them.

I warrant and represent in respect of all entries that I submitted that (i) the entry is my original work, created solely by me, and over which I have all necessary rights, title and interest, including copyright; (ii) my entry has not been previously published; (iii) my entry does not infringe upon the intellectual property rights, or defame or invade the publicity or privacy rights, of any third party, living or deceased; (iv) all individuals appearing my entry have granted to me an irrevocable, royalty-free, worldwide license in perpetuity to publish or otherwise use their likeness in the entry in any manner and media whether now known or hereafter devised, including without limitation on any website associated with the Competition; and, (v) my entry complies with the entry requirements set out in the attached Competition Rules. #### **Competition Rules**

#### INGENIOUS+ YOUTH INNOVATION AWARD

#### COMPETITION

#### **RULES AND REGULATIONS**

#### ELIGIBILITY

Only Canadian residents are eligible to participate in the Ingenious + Youth Innovation Award competition (the "Competition"). Entrants must be between the ages of 14 and 18 (have reached their 14<sup>th</sup> birthday and not yet reached their 19<sup>th</sup> birthday at the time of entry). All entrants must complete and sign a declaration and release form (the "Release") to enter the Competition. Entrants who have not reached the age of majority in their province or territory of residence at the time of entry must also have a parent or legal guardian sign the Release. In the event of a group, all members must meet the age and residency requirements above and one individual must be identified as the group's primary contact. If a group is chosen as an award recipient under the Competition, the group's primary contact will be the individual contacted by the Ingenious+ program. A group must have no more than five (5) members.

Winners of a National Award during the 2022/2023 Competition are not eligible to participate in this year's Competition.

Entrants must be the sole owner (or co-owners, in the case of a group entry) of all right, title and interest (including copyright) in and to the content of the entry submitted in connection with the Competition.

Employees, officers, directors, agents or representatives of the Rideau Hall Foundation and each of its affiliates, parents, subsidiaries, related companies, advertising and promotional agencies and any individual or entity involved in the development, production, implementation, administration, judging or fulfillment of the Competition (collectively, the "Competition Parties") and the immediate family and household members of any of the above (whether or not related), are not eligible to participate in the Contest. For the purposes of these Contest rules, "immediate family" means husband, wife, spouse, mother, father, brother, sister, son, and/or daughter, whether or not they reside in the same household.

The Rideau Hall Foundation will determine the eligibility of all entrants at all levels of the award program. Its decision on eligibility is final.

All entrants must comply with these rules (the "Competition Rules"). Entry in the Competition constitutes acceptance of the Competition Rules.

#### HOW TO ENTER

To enter, complete and submit the online entry form located at <u>https://ingeniousplus.ca/apply-now</u> (the "Competition Website") along with the Consent and the Ingenious+ Youth Innovation Challenge submission you are entering in the Competition (the "Submission").

#### **Regional Awards**

All entrants must submit an online entry form and/or video including the information required in this application form <u>https://ingeniousplus.ca/apply-now</u> to enter and to qualify for selection for a regional award ("Regional Award") under the Competition. Submissions for the Regional Awards

will be accepted from October 17<sup>th</sup>, 2023 to March 10<sup>th</sup> 2024 at 11:59 p.m. PST (the "Submission Period").

The completed entry, including the Submission, supporting materials and completed Release must be submitted no later than March 10<sup>th</sup>, 2024 at 11:59 p.m. PST to be counted as received during the Submission Period.

Entrants may submit more than one entry in any given year. There is no limit.

# **National Finalist Awards**

National Finalist awards ("National Finalist Awards") shall only be available to successful recipients of a Regional Award, unless otherwise determined by the Rideau Hall Foundation in its sole discretion.

Entrants who wish to be considered for a National Finalist Award must indicate their choice on their entry form. Regional Award winners who indicated on their entry form that they wished to be considered for a National Finalist Award are automatically entered into the national competition, and their materials from the regional process (entry form, consent forms, completed Release) constitute the materials to be considered for the National Finalist Award. If an entrant changes their mind and does not wish to participate in the National Finalist Award part of the Competition, they must withdraw their Submission by March 24<sup>th</sup>, 2024. Entrants who opt out of the national competition cannot decide to opt in at a later date.

#### **National Awards**

National awards ("National Awards") shall only be available to successful recipients of a Regional Award, unless otherwise determined by the Rideau Hall Foundation in its sole discretion. Recipients of the National Finalist Awards are not eligible to receive a National Award. If there are not at least 30 Regional Award recipients who carry on to the national competition, additional Submissions for the national competition may be sought at the discretion of the Rideau Hall Foundation. These Submissions will be required to be in the same format and follow the same entry process as all other Submissions, and will be required to be submitted by March 24th, 2024 at 11:59 p.m. PST to be counted as received during the Submission Period.

Entrants who wish to be considered for a National Award must indicate their choice on their entry form. Regional Award winners who indicated on their entry form that they wished to be considered for a National Award are automatically entered into the national competition, and their materials from the regional process (entry form, consent forms, completed Release) constitute the materials to be considered for the National Award. If an entrant changes their mind and does not wish to participate in the National Award part of the Competition, they must withdraw their Submission by March 24<sup>th</sup>, 2024. Entrants who opt out of the national competition cannot decide to opt in at a later date.

# CONSENT AND RELEASE

All entrants, including all members of a group, must provide an executed Release by the prescribed method before their Submission will be considered complete and submitted. Entrants who have not reached the age of majority in their province or territory of residence, must also have a parent or legal guardian execute the Release. The signed Release must be uploaded via the Competition Website at the following link: <u>https://ingeniousplus.ca/apply-now</u>. In the absence of a valid Release for a member of a group, that individual group member will be ineligible for competition, while the remaining members of the group may continue in the Competition.

# JUDGING CRITERIA

Submissions must be submitted under one or more of the following categories "Categories"):

- Climate Change & the Environment
- Community & Civic Engagement
- Entrepreneurship & Technology

- Equity & Inclusion
- Health & Well-being

All entries will be evaluated using the following evaluation criteria ("Judging Criteria"):

#### Problem or Opportunity Being Addressed (5 points):

- Clear and compelling description of the problem or opportunity.
- Justification for why the innovation project is needed.

# Solution (10 points):

- Submission is an innovation\*
- Clear and concise explanation of the innovation.
- Demonstrates a unique and creative solution.

#### **Research Done (5 points):**

- Evidence of community, background, expert, and/or market research conducted.
- Shows understanding of the problem space and potential challenges.

#### Expected Impact (10 points):

- Clearly identifies the target users or beneficiaries of the innovation.
- Describes concrete ways the innovation will improve the lives of the target users or beneficiaries.

#### Feasibility of Implementing the Innovation (10 points):

- Presents a well-thought-out plan for full implementation of the innovation.
- Addresses potential barriers and offers feasible solutions.

# Collaboration (5 points):

- Identifies relevant collaborators and community partnerships.
- Explains how these collaborations will support the innovation throughout the process.
- •

#### Plans For Use of Award (5 points):

- Provides a clear and detailed plan for how the cash award will be used to support the innovation.
- Shows a strategic approach to utilizing the funds for maximum impact.

#### \*Definition of Innovation

Innovation is something different that has an impact. It might be improving upon or innovating a product, service, or process, or creating something new that solves a problem or makes the world a better place.

The project should be advanced beyond the idea or concept stage and have demonstrated that it has been put into action. Projects do not have to be full-fledged innovations, commercialized, or have the ability to monetize, e.g., social or community innovations may have different valuable impacts.

The evaluations will be done by evaluators for the Regional Awards and by national judges for the National Finalist Awards and National Awards. The evaluators and judges will base their choice of award recipients on the above-mentioned Judging Criteria. Evaluators and judges will reach their decisions by consensus.

All decisions of the evaluators and judges at the regional and national levels are final and binding. The judging scores for any entry will not be revealed.

# AWARDS

If a group is chosen for an award under the Competition, the cash award will be distributed equally amongst the group members. Cash awards are provided by cheque or Electronic Funds Transfer ("EFT") to each individual.

#### **Regional Awards**

There are up to 100 \$1,000 Regional Awards available this year, 25 in BC/YK/NT, 20 in AB/SK/MB, 35 in ON, 20 in QC/NB/NL/PE/NS/NU. Entrants from other locations will be assigned to one of these four regions and their submission judged fairly and transparently alongside Submissions from that region.

Regional Awards each consist of:

- \$1,000 for the purposes of developing, improving, and implementing the innovation submitted in the Competition; and
- the opportunity to attend 4-5 virtual group learning and mentorship sessions (approx. value \$100 each).

Regional Award recipients will be invited to attend a regional celebration, which will be held between March and May 2024.

#### National Finalist Awards

There are up to 13 National Finalist Awards available, up to 1 for each province or territory. National Finalist Awards will be awarded to outstanding Submissions for exceptional innovations, regardless of Category, as determined by the national judges. The national judges may choose not to award a National Finalist Award for any particular province or territory if in their determination there is not 1 Submission in each province or territory which qualifies as an outstanding Submissions for an exceptional innovation.

National Finalist Awards each consist of:

- \$1,000 for the purposes of developing, improving, and implementing the innovation submitted in the Competition;
- the opportunity to attend 3 virtual group learning and mentorship sessions (approx. value \$250 each); and

National Finalist Award winners will be invited to attend a national in-person celebration in Ottawa during Canadian Innovation Week (May 13<sup>th</sup>-17<sup>th</sup>, 2024).

#### **National Awards**

Recipients of the **National Finalist Awards** are not eligible to receive a National Award. There are 5 National Awards available, 1 for each Category. National Awards will be awarded to the top Submission from the regional winners in each Category, as determined by the national judges.

National Awards each consist of:

- \$10,000 for the purposes of developing, improving, and implementing the innovation submitted in the Competition;
- the opportunity to attend 3 virtual group learning and mentorship sessions (approx. value \$250 each); and

National Award winners will be invited to attend a national in-person celebration in Ottawa during Canadian Innovation Week (May 13<sup>h</sup>-17<sup>th</sup>, 2024).

# WINNER SELECTION AND NOTIFICATION

Regional Award recipients will be determined by May 13, 2024, and cash awards issued by cheque or by EFT by June 30, 2024; National Finalist Award recipients and National Award recipients will be determined by May 13, 2024, and cash awards issued by cheque or by EFT by July 31, 2024.

Awards must be accepted as described in the Competition Rules and cannot be transferred to another person or substituted for another award. Any substitution of an award, in whole or in part, is at the sole discretion of the Rideau Hall Foundation.

All winners will be contacted by telephone or by email and must have executed and submitted a Release in order to win.

As a condition of receiving an award, all winners will be required to use the monetary portions of their award for the purposes of developing, improving, and implementing their innovation. Determination of whether a winner's activities comply with this requirement will be in the sole discretion of the Rideau Hall Foundation and supporting documentation, such as receipts, may be requested. Examples of acceptable uses of awards include, but are not limited to, purchasing materials for the innovation, marketing costs, registration of websites, purchasing equipment, and transportation costs. All winners will also be required to complete an end-of-year survey sent to them electronically or otherwise by the Rideau Hall Foundation seeking feedback on the Competition and a description of how the winner used the monetary and non-monetary portions of their award to develop, improve, or implement their innovation. In addition to these requirements, winners of the National Awards will be required to provide a progress report to the Rideau Hall Foundation three (3) months after receipt of their award. The progress report (a) must contain an update on the status of the winner's innovation and how the winner used the monetary and non-monetary portions of their award to develop, improve, or implement their innovation and (b) must be submitted to the Rideau Hall Foundation at the date specified by the Rideau Hall Foundation.

If a winner fails to (a) use an award for the purposes of developing, improving, or implementing their innovation, (b) complete the end-of-year survey as required, or (c) complete and send the progress report as required (for National Award winners only), the Rideau Hall Foundation, in its sole discretion, may require repayment of the monetary portion of the award.

The odds of winning depend on the number of eligible entries received and the decisions of the judges.

#### PUBLICITY

All award winners (including all members of a group) may be recognized on the Competition Website by name, city and province or territory of residence and photos.

# TRAVEL

The Regional Award recipients will be celebrated at an in-person regional event hosted by the Rideau Hall Foundation and/or a Delivery Partner in each region between March and May 2024. The National Finalist Award and National Award recipients will be celebrated at an in-person event in Ottawa hosted by the Rideau Hall Foundation during Canadian Innovation Week, May 13<sup>th</sup> to 17<sup>th</sup>, 2024. Where necessary and only if possible dependent on health and safety travel restrictions, transportation to the city location of the regional and/or national celebration (the "**Destination**"), in economy class, and overnight accommodations (1 night at a hotel arranged by the Rideau Hall Foundation or on its behalf) for award recipients and a parent or legal guardian if the winner is under the age of majority in their province or territory of residence (based on standard room, double occupancy), will be provided by Rideau Hall Foundation up to a maximum cost of \$3,000 per winner and \$3,000 per parent or legal guardian, in line with the RHF Travel Directive, which will be provided at the time of travel arrangement. Transportation will be from the major airport nearest the award recipient's residence, selected at the discretion of the Rideau Hall Foundation (the "Departure Point").

In the event of a group entry is selected as winner of one of the awards, all members of the group will be invited using the email address provided on their respective Releases to attend the event. #### **Competition Rules**

#### INGENIOUS+ YOUTH INNOVATION AWARD

#### COMPETITION

#### RULES AND REGULATIONS

#### ELIGIBILITY

Only Canadian residents are eligible to participate in the Ingenious + Youth Innovation Award competition (the "Competition"). Entrants must be between the ages of 14 and 18 (have reached their 14<sup>th</sup> birthday and not yet reached their 19<sup>th</sup> birthday at the time of entry). All entrants must complete and sign a declaration and release form (the "Release") to enter the Competition. Entrants who have not reached the age of majority in their province or territory of residence at the time of entry must also have a parent or legal guardian sign the Release. In the event of a group, all members must meet the age and residency requirements above and one individual must be identified as the group's primary contact. If a group is chosen as an award recipient under the Competition, the group's primary contact will be the individual contacted by the Ingenious+ program. A group must have no more than five (5) members.

Winners of a National Award during the 2022/2023 Competition are not eligible to participate in this year's Competition.

Entrants must be the sole owner (or co-owners, in the case of a group entry) of all right, title and interest (including copyright) in and to the content of the entry submitted in connection with the Competition.

Employees, officers, directors, agents or representatives of the Rideau Hall Foundation and each of its affiliates, parents, subsidiaries, related companies, advertising and promotional agencies and any individual or entity involved in the development, production, implementation, administration, judging or fulfillment of the Competition (collectively, the "Competition Parties") and the immediate family and household members of any of the above (whether or not related), are not eligible to participate in the Contest. - Climate Change & the Environment
- Community & Civic Engagement

- Entrepreneurship & Technology
- Equity & Inclusion
- Health & Well-being

All entries will be evaluated using the following evaluation criteria ("Judging Criteria"):

# Problem or Opportunity Being Addressed (5 points):

- Clear and compelling description of the problem or opportunity.
- Justification for why the innovation project is needed.

# Solution (10 points):

- Submission is an innovation\*
- Clear and concise explanation of the innovation.
- Demonstrates a unique and creative solution.

# **Research Done (5 points):**

- Evidence of community, background, expert, and/or market research conducted.
- Shows understanding of the problem space and potential challenges.

# Expected Impact (10 points):

- Clearly identifies the target users or beneficiaries of the innovation.
- Describes concrete ways the innovation will improve the lives of the target users or beneficiaries.

# Feasibility of Implementing the Innovation (10 points):

- Presents a well-thought-out plan for full implementation of the innovation.
- Addresses potential barriers and offers feasible solutions.

# Collaboration (5 points):

- Identifies relevant collaborators and community partnerships.
- Explains how these collaborations will support the innovation throughout the process.

# Plans For Use of Award (5 points):

- Provides a clear and detailed plan for how the cash award will be used to support the innovation.
- Shows a strategic approach to utilizing the funds for maximum impact.

# \*Definition of Innovation

Innovation is something different that has an impact. It might be improving upon or innovating a product, service, or process, or creating something new that solves a problem or makes the world a better place.

The project should be advanced beyond the idea or concept stage and have demonstrated that it has been put into action. Projects do not have to be full-fledged innovations, commercialized, or have the ability to monetize, e.g., social or community innovations may have different valuable impacts.

The evaluations will be done by evaluators for the Regional Awards and by national judges for the National Finalist Awards and National Awards. The evaluators and judges will base their choice of award recipients on the above-mentioned Judging Criteria. Evaluators and judges will reach their decisions by consensus.

All decisions of the evaluators and judges at the regional and national levels are final and binding. The judging scores for any entry will not be revealed.

# AWARDS

If a group is chosen for an award under the Competition, the cash award will be distributed equally amongst the group members. Cash awards are provided by cheque or Electronic Funds Transfer ("EFT") to each individual.

# **Regional Awards**

There are up to 100 \$1,000 Regional Awards available this year, 25 in BC/YK/NT, 20 in AB/SK/MB, 35 in ON, 20 in QC/NB/NL/PE/NS/NU. Entrants from other locations will be assigned to one of these four regions and their submission judged fairly and transparently alongside Submissions from that region.

Regional Awards each consist of:

- \$1,000 for the purposes of developing, improving, and implementing the innovation submitted in the Competition; and
- the opportunity to attend 4-5 virtual group learning and mentorship sessions (approx. value \$100 each).

Regional Award recipients will be invited to attend a regional celebration, which will be held between March and May 2024.

#### National Finalist Awards

There are up to 13 National Finalist Awards available, up to 1 for each province or territory. National Finalist Awards will be awarded to outstanding Submissions for exceptional innovations, regardless of Category, as determined by the national judges. The national judges may choose not to award a National Finalist Award for any particular province or territory if in their determination there is not 1 Submission in each province or territory which qualifies as an outstanding Submissions for an exceptional innovation.

National Finalist Awards each consist of:

- \$1,000 for the purposes of developing, improving, and implementing the innovation submitted in the Competition;
- the opportunity to attend 3 virtual group learning and mentorship sessions (approx. value \$250 each); and

National Finalist Award winners will be invited to attend a national in-person celebration in Ottawa during Canadian Innovation Week (May 13<sup>th</sup>-17<sup>th</sup>, 2024).

#### **National Awards**

Recipients of the **National Finalist Awards** are not eligible to receive a National Award. There are 5 National Awards available, 1 for each Category. National Awards will be awarded to the top Submission from the regional winners in each Category, as determined by the national judges.

National Awards each consist of:

- \$10,000 for the purposes of developing, improving, and implementing the innovation submitted in the Competition;
- the opportunity to attend 3 virtual group learning and mentorship sessions (approx. value \$250 each); and

National Award winners will be invited to attend a national in-person celebration in Ottawa during Canadian Innovation Week (May 13<sup>h</sup>-17<sup>th</sup>, 2024).

#### WINNER SELECTION AND NOTIFICATION

Regional Award recipients will be determined by May 13, 2024, and cash awards issued by cheque or by EFT by June 30, 2024; National Finalist Award recipients and National Award recipients will be determined by May 13, 2024, and cash awards issued by cheque or by EFT by July 31, 2024.

Awards must be accepted as described in the Competition Rules and cannot be transferred to another person or substituted for another award. Any substitution of an award, in whole or in part, is at the sole discretion of the Rideau Hall Foundation.

All winners will be contacted by telephone or by email and must have executed and submitted a Release in order to win.

As a condition of receiving an award, all winners will be required to use the monetary portions of their award for the purposes of developing, improving, and implementing their innovation. Determination of whether a winner's activities comply with this requirement will be in the sole discretion of the Rideau Hall Foundation and supporting documentation, such as receipts, may be requested. Examples of acceptable uses of awards include, but are not limited to, purchasing materials for the innovation, marketing costs, registration of websites, purchasing equipment, and transportation costs. All winners will also be required to complete an end-of-vear survey sent to them electronically or otherwise by the Rideau Hall Foundation seeking feedback on the Competition and a description of how the winner used the monetary and non-monetary portions of their award to develop, improve, or implement their innovation. In addition to these requirements, winners of the National Awards will be required to provide a progress report to the Rideau Hall Foundation three (3) months after receipt of their award. The progress report (a) must contain an update on the status of the winner's innovation and how the winner used the monetary and non-monetary portions of their award to develop, improve, or implement their innovation and (b) must be submitted to the Rideau Hall Foundation at the date specified by the Rideau Hall Foundation.

If a winner fails to (a) use an award for the purposes of developing, improving, or implementing their innovation, (b) complete the end-of-year survey as required, or (c) complete and send the progress report as required (for National Award winners only), the Rideau Hall Foundation, in its sole discretion, may require repayment of the monetary portion of the award.

The odds of winning depend on the number of eligible entries received and the decisions of the judges.

#### PUBLICITY

All award winners (including all members of a group) may be recognized on the Competition Website by name, city and province or territory of residence and photos.

All recipients of awards under the Competition (including each group member in the event of a group submission) agree to make themselves available for media interviews and by accepting an award under the Competition, consent to the use of their name, image, photograph, likeness, voice, and city of residence and related visual/sound recordings by the Rideau Hall Foundation, without the expectation of further remuneration or notice in connection with the award and for publicity purposes relating exclusively to the Competition in any media or format whatsoever at any time or times in perpetuity.

Each entrant acknowledges that the Rideau Hall Foundation has no control over and is not responsible for any use or misuse including, but not limited to, any alteration, modification, reuse, or distortion of their Submission (or the entrant's name, image, photograph, likeness, voice, and city of residence) that may occur or be caused by third parties. # TRAVEL

The Regional Award recipients will be celebrated at an in-person regional event hosted by the Rideau Hall Foundation and/or a Delivery Partner in each region between March and May 2024. The National Finalist Award and National Award recipients will be celebrated at an in-person event in Ottawa hosted by the Rideau Hall Foundation during Canadian Innovation Week, May 13<sup>th</sup> to 17<sup>th</sup>, 2024. Where necessary and only if possible dependent on health and safety travel restrictions, transportation to the city location of the regional and/or national celebration (the "**Destination**"), in economy class, and overnight accommodations (1 night at a hotel arranged by the Rideau Hall Foundation or on its behalf) for award recipients and a parent or legal guardian if the winner is under the age of majority in their province or territory of residence (based on standard room, double occupancy), will be provided by Rideau Hall Foundation up to a maximum cost of \$3,000 per winner and \$3,000 per parent or legal guardian, in line with the RHF Travel Directive, which will be provided at the time of travel arrangement. Transportation will be from the major airport nearest the award recipient's residence, selected at the discretion of the Rideau Hall Foundation (the "Departure Point").

In the event of a group entry is selected as winner of one of the awards, all members of the group will be invited using the email address provided on their respective Releases to attend the event. However, the Rideau Hall Foundation will only cover the travel and accommodation costs (up to \$3,000) of the group's primary contact as identified on the entry form, and his or her legal guardian (up to \$3,000), if the contact is under the age of majority in their province or territory of residence. Notwithstanding anything to the contrary, should the group's primary contact be unable or unwilling to attend, the group may request an alternate participant to attend on behalf of the group.

Any other costs or expenses associated with the awards not specified herein will be the responsibility of selected award winners and their parent/legal guardian (as applicable), including without limitation ground transportation to/from the Departure Point, meals, communication charges, room service, gratuities, optional tours, insurance, and medical travel documents. The

Rideau Hall Foundation will not be responsible if weather conditions, event cancellations, or other factors beyond their reasonable control prevent the transportation and accommodation provisions outlined above form being fulfilled, and the award recipient will not be entitled to compensation in lieu thereof. The award recipients and their parents/legal guardians must have no restrictions on their ability to travel. The award recipients and their parents/legal guardians are responsible for obtaining all necessary travel documentation and permissions and must travel on the same itinerary. The award recipients and their parents/guardians must travel on the dates and travel carriers and stay at the accommodations as determined by the Rideau Hall Foundation in its sole discretion. The Rideau Hall Foundation will not be responsible if an award recipient or parent/legal guardian is denied entry onto aircraft, into the Destination, or return entry into the Departure Point. In such a situation, the award recipients and their parents/legal guardians will be responsible for any and all additional costs incurred. In the event that a national award recipient resides within a 350-kilometer radius of the Destination, ground transportation (including without limitation train transportation) may be awarded and no compensation or substitution will be provided for the difference in cost (if applicable). The award recipients and their parents/legal guardians must obey all hotel and celebration event rules and requirements, including the hotel requirement to present a major credit card. Failure to follow such hotel and event rules and requirements may result in, without limitation, ejection from the event, non-admission to hotel and forfeiture of all or part of the award. In the event an award recipients or their parent/legal guardian engages in behavior that (as determined by the Rideau Hall Foundation in its sole discretion) is obnoxious or threatening, illegal, or that is intended to annoy, abuse, threaten, or harass any other person, the Rideau Hall Foundation reserve the right to terminate the trip early and send the award recipient and parent/legal guardian home with no further compensation.

#### **TERMS OF PARTICIPATION**

- Submitted entries shall not be returned to candidates.
- Multiple entries are permitted. The National Award winners are ineligible for future Ingenious+ Youth Innovation Challenge competitions. All other entrants are free to enter for future Ingenious+ Youth Innovation Challenge competitions.
- An entrant's submission must not include any content whatsoever which would reasonably be understood to be defamatory, threatening, distasteful, racist, unlawful, or otherwise objectionable or would infringe the intellectual property rights of third parties.

The Rideau Hall Foundation shall not be responsible for any technical malfunctions that are human, mechanical, or technical in nature, or any combination thereof, including any injury as well as lost, incomplete, destroyed, misdirected, illegible or late submissions which for any reason are not received.

The Rideau Hall Foundation assumes no responsibility for lost or late submissions of entries.
